ITEM NO. (1)

CONFIRMATION OF THE MINUTES OF THE LAST EXECUTIVE COMMITTEE MEETING HELD ON 26TH AUGUST, 2019

The Minutes of the last Executive Committee Meeting of POA held on 26th August, 2019 at Pakistan Olympic House, Lahore were circulated to all the members of the Executive Committee vide POA Letter No. POA-395 / MS / ECM/ 050 dated 24th September, 2019 with the request to send comments / observations if any, regarding correctness of the Minutes within 10 days of the issuance of this letter, otherwise it would be presumed that the Minutes were correctly recorded.

Decision:

The house unanimously approved the Minutes of the last Executive Committee Meeting of POA held on 26th August, 2019 at Olympic House, Lahore.

ITEM NO. (2) TOKYO 2020 OLYMPIC GAMES - 24TH JULY - 09 AUGUST, 2020

The house was informed that the Tokyo 2020 Olympic Games are scheduled from 24th July to 09th August, 2020 at Japan. The qualification rounds of different sports are still underway and will continue till the end of June, 2020. The following athletes have qualified for participation in the Games so far and the concerned Federations have been requested to provide relevant data / documents for accreditation purpose:-

It was also informed that Pakistan Olympic Association has also applied for Invitation Places to the Olympic Games Tripartite Commission for the following sports:-

- Karate
- Weightlifting
- Judo
- Taekwondo
- Gymnastics

It is the discretion of Tripartite Commission to allocate Invitation Places keeping in view the number of applications which is generally higher than the number of places available, thus not all eligible NOCs can be allocated an Invitation Place. However POA has made the necessary applications and awaits the decision. The status of Universality Places in Athletics and Swimming has to be allocated by IAAF and FINA respectively as these places are not managed by the Tripartite Commission.

Decision:

The house congratulated the qualified athletes for their brilliant performances and appreciated the efforts of the National Rifle Shooting Association of Pakistan, Equestrian Federation of Pakistan, and Athletics Federation of Pakistan. The house unanimously approved the participation of Pakistan Contingent in the Tokyo Olympic Games and authorized the President POA to take all financial and administrative measures for the successful participation of the Pakistan Contingent in the Tokyo Olympic Games.

ITEM NO. (3) 6TH ASIAN BEACH GAMES SANYA, CHINA – 28TH NOVEMBER TO 06th DECEMBER, 2020

The house was informed that 6th Asian Beach Games are scheduled from 28th November to 06th December, 2020 at Sanya, China. 18 x Sports Disciplines have been included in these Games. Pakistan Olympic Association has sent the Entry by Sport for the following sports disciplines to the Organizing Committee of the Games at the first instance and subject to availability of funds with the Government or the concerned Federations:-

Decision:

The house approved the participation of Pakistan Contingent in the Games and authorized the President POA to take administrative and financial measures for the participation of the Pakistan Contingent in the 6th Asian Beach Games subject to availability of funds with the Government or the concerned National Sports Federations.

Brig. Muhammad Zaheer Akhtar, Vice President, POA offered the house that Pakistan Army Sports Directorate can take responsibility of 5 - 6 sports (where Army has top position) for their

preparation and training under the patronage of Pakistan Army with an aim to bring laurels for nation in the forthcoming 14th South Asian Games in Pakistan.

Decision:

The house authorized the President POA to constitute the Core Committee of POA under his leadership to take all necessary decisions, implementation, budgeting and execution of the Games in a befitting manner in Pakistan and include any member in the Committee as and when required for the smooth and better working. The house also decided to deliberate and decide about the proposal of the Brig. Muhammad Zaheer Akhtar, Vice President POA in consultation with National Sports Federations concerned. It was further decided that above coordination groups shall be notified with the approval of President POA after consulting the group leaders and respective National Sports Federations.

ITEM NO. (6) ANY OTHER MATTER WITH THE PERMISSION OF THE CHAIR

- 1. The house took note of certain offices in Federations or within their members are holding one or more elected offices in various Federations. It was informed that according to Constitution of POA, the elected office bearers of an affiliated National Sport Federation shall not hold any elected position in any other National Sports Federation as well as Provincial Sports Associations. This shall enable inclusion of more individuals in the Olympic Movement. The house directed to ensure implementation and adoption of this clause by all office bearers of the National Federation and a report to this effect shall be submitted by POA within <u>six</u> months of issuing of the minutes. The President POA was authorized to take suitable measures to ensure implementation of this clause.
- 2. On a guery raised by the members of the Executive Committee, it was discussed in detail and decided that the Constitution of Provincial Olympic Association should be in line with the Constitution of Pakistan Olympic Association and the process of amending Constitutions should be completed following all legal formalities. It was further noted that the creation of the Provincial Sports Associations is the prerogative of the National Federation and once the Provincial Sports Association is affiliated with a Provincial Olympic Association, the Provincial Sports Association does not require to be re-affiliated rather the Provincial Olympic Association is mandated to observe and recognize the electoral proceedings of the Provincial Sports Association. However in case of dispute, the resolution mechanism are provided in the Constitution of POA. On the query regarding the parallel sports associations created by certain groups during the period 2012 - 2016 it was noted that the provincial sports associations created by few National Federations, that also attempted to forge a parallel body to POA. cannot be recognized till the process of validation and verification is completed. It was further decided that the process of Amendments to the Constitution of KP Olympic Association and its subsequent approval leading to the Elections shall be monitored and final recommendations shall be made by the POA Constitution and Affiliation Committee.
- The Executive Committee approved by passing following resolution:-

"Resolved that all necessary documents be provided to the Bank for maintenance of the accounts of the association and for remittance related operations in these accounts".

"Resolved that all the Bank Accounts of Pakistan Olympic Association shall be operated jointly by Mr. Muhammad Khalid Mahmood, Secretary General and Mr. Muhammad Shafiq, Treasurer of Pakistan Olympic Association".

"Resolved that any change in custodianship, control and operation of accounts be communicated to the Bank immediately".

- 4. The query of Pakistan Army regarding the legal status of WAPDA Sports Board was discussed. The President POA opined that since this issue requires in-depth deliberation as WAPDA Sports Board is parent department of thousands of athletes and has played pivotal role in the development of national sports. The POA Constitution and Affiliation Committee was assigned to examine the recent changes in the organizational structure and recommend the status of WAPDA Sports Board for the consideration of POA in its next General Council meeting.
- 5. The house was informed about certain cases lodged that the athletes represented other organizations instead of their parent bodies / employer. President POA opined that this issue can be resolved once Federations opt registration mechanism for their respective Athletes / Games. The house unanimously resolved to ensure adoption of a system for registration of athletes so that such reports does not emerge in the 34th National Games.

The meeting ended with a vote of thanks to the Chair and the chair also thanked all members of the Executive Committee for their participation.
