RULES OF INTER-PROVINCIAL GAMES

In order to foster the spirit of friendship, harmony, solidarity and to develop sports/athletes in all provinces of the country, the Inter-Provincial Games were introduced and the inaugural Event was hosted by the Punjab Olympic Association in 2003 under the umbrella/ auspices of Pakistan Olympic Association. These Games to be held every four years on rotation basis by each Provinces/ Provincial /Other Olympic Association but not clashing with Olympic/Commonwealth/Asian/South Asian /National Games.

RULE 1

ELIGIBILITY OF THE PARTICIPATING UNITS IN THE INTER PROVINCIAL GAMES

1.1 Only the affiliated Units of the Pakistan Olympic Association (POA) are entitled to participate and compete in the Inter Provincial Games in all the Individual Sports and Team Sports included in the programme of the Games, in accordance with the rules mentioned hereinafter.

1.2 Presently following are the affiliated Units of POA which are entitled for participation in the Games:-

- i. Balochistan Olympic Association
- ii. FATA Olympic Association
- iii. Islamabad Olympic Association
- iv. KP Olympic Association
- v. Punjab Olympic Association
- vi. Sindh Olympic Association
- vii. Any other Unit that may be given playing rights/affiliation by POA

RULE 2

ALLOTMENT OF THE INTER PROVINCIAL GAMES

The POA in the normal course should preferably allot the Inter Provincial Games atleast one month before the commencement of the previous Inter Provincial Games so that the Inter Provincial Games Flag may be formally handed over to the next host Unit of POA / Provincial Olympic Association at the Closing Ceremony. However the POA General Council/Executive Committee/President may allot the National Games any time later if deemed appropriate due to emergent situations/unavoidable circumstances.

RULE 3

FINALIZATION OF DATES, SPORTS AND SPORTS DISCIPLINES AND THEIR CIRCULATION

3.1 At least four months before the commencement of the Inter Provincial Games, the concerned affiliated Unit of POA/Provincial Olympic Association hosting the Inter Provincial Games / Organizing Committee shall decide, in consultation with the POA, the dates, Sports and Sports disciplines to be included in the programme of the Inter Provincial Games, which must have duration of atleast 5 days.

3.2 Efforts shall be made in consultation with the POA Sports Commission to include all Sports (Men and Women) with their disciplines whose National Federations are affiliated with POA subject to following consideration/conditions:

- i. Good standing with POA and Provincial Olympic Association.
- ii. Availability of requisite facilities/infrastructure with host Unit.
- iii. Confirmation by respective National Sports Federations.
- iv. Confirmation of participation of atleast 4 x Units.
- v. Events to be as per latest National Games of respective Individual Sports (Men/Women) or less subject to approval of POA Sports Commission.

3.3 The size and strength of the Provincial Contingents shall be decided by the POA Sports Commission and the Provinces will participate in the Inter Provincial Games according to their choice within the size allotted to them. However there shall be Women participation of atleast 30% of the total strength of Athletes /Players/competitors.

3.3 The decision of the dates and the sports disciplines must be circulated by the hosting POA Unit/Provincial Olympic Association and the Pakistan Olympic Association to all the participating POA Units within 15 days of such decisions. The participating Units shall submit their confirmation of participation with Number in each sport discipline to the hosting Unit/Provincial Olympic Association / Organizing Committee under intimation to the POA within 90 days of the receipt of intimation from the concerned hosting Unit/Provincial Olympic Association/ Organizing Committee.

RULE 4

PARTICIPATION ELIGIBILITY OF ATHLETES

4.1 Athletes/ Players/ Competitors and Contingent officials (CDM/DyCDM/ Secretary) Team Officials (Manager/ Coach) belonging to each province shall be eligible to participate and represent their Province/organization in the Inter Provincial Games.

4.2 Maximum age limit for each athlete/ player/ competitor and team shall be 25 years as on last day of the Games.

4.3 No athlete/ player/ competitor who is presently serving or has represented in the past any Departmental/Services Organization affiliated with POA in the previous National Games will be eligible to participate in the Inter Provincial Games because these Games are entirely aimed at promoting sports of the Provinces. However students belonging to Higher Education Commission (HEC) can represent the Province of his / her domicile.

4.4 All athletes/ players/ competitors/officials must bring along their Current and valid CNIC and Domicile.

RULE 5

Entries

5.1 In Team Sports of each Province/Unit shall enter one (1) team only.

5.2 In Individual Sports the maximum entries from each participating Province/unit shall not be more than two (2) in each event.

5.3 In Team Event of Individual Sports there shall not be more than one (1) Team from Each Province.

5.4 To hold competitions of events there shall competitors of at least 3 participating units.

RULE 6

CONDUCT OF EVENTS AND FINALIZATION OF PROVINCIAL CONTINGENT

6.1 Event shall be conducted by the respective Sports Association affiliated with host Provincial Olympic Association (affiliated with POA) and recognized by NSF concerned (affiliated with IF recognized by IOC). In case of dispute, host Provincial Olympic Association in consultation with POA shall formulate a Committee to hold the competition.

6.2 Since selection / finalization of provincial contingent is prerogative of the Provincial Olympic Association therefore Selection of athletes and team management (coaches and managers) for participation in the Games shall be entire authority of the respective Provincial Olympic Association.

RULE 7

MEETINGS

7.1 The first meeting of the Secretaries of the concerned National Sports Federations and Provincial Sports Association alongwith the representatives of the participating Units shall be held atleast one month before the commencement of the Games to discuss and decide the detailed technical requirements of the competitions

7.2 A second meeting Secretaries of the concerned National Sports Federations and Provincial Sports Association alongwith the representatives of the participating Units to be held atleast 10 days before the Games in which besides other matters, the draws of all the competitions would be held by the Secretaries of the concerned National Federations. In both these meetings the POA representatives would also be present. The decisions of the meeting including finalization of events in each sport shall be circulated by Secretary General POA which shall be final. No Federation will add up or reduce events at its own beyond the approved and circulated events by POA.

7.3 During these above meetings the organizing Committee shall provide boarding, lodging, local transport and Air Travel / AC Train/ AC Bus (where applicable) to one delegate of NSFs and participating units.

RULE 8

PROTOCOL ON OPENING AND CLOSING CEREMONIES AND PROGRAMME OF COMPETITIONS ON THE OPENING AND CLOSING DAYS.

8.1 The Opening and Closing Ceremonies of the Inter Provincial Games shall be held in accordance with the protocols on the pattern of the Olympic Games / Asian Games as indicated in the bye-laws of the Olympic Charter/Constitution and Rules of OCA.

8.2 Any competition programme held on the Opening day of the Inter Provincial Games must be completed atleast 4 hours before the Opening Ceremony. However the Organizing Committee may start competitions earlier than the start of the Games in any sport which takes longer time so that the competition programme of such a Sport is completed a day before the closing of the Games. The following events can be held in presence of the Chief Guest before the start of the Closing Ceremony:-

- i. Any Exhibition Sport, and
- ii. Cultural programmes

RULE 9

AWARD OF POINTS FOR TROPHIES

9.1 The "Governors Trophy" will be awarded to the Unit getting the highest number of Points. The "Chief Minister Trophy" will be awarded to the Unit getting 2nd Position in the Table Points. Similarly Brig Rodham Trophy shall be awarded to the unit getting overall 3rd place on the Table Points. President POA Trophy (Fairplay) shall be awarded a Participating Unit who displays the best disciplines and sportsmanship during the Games. The following formula of Points shall be operative:-

9.2 INDIVIDUAL EVENTS /SPORTS

Note: In sports disciplines where the evaluation is based on test and measurement, 10 additional points will be awarded to a competitor when he/she equalizes the previous National Record and 15 additional points will be awarded to a competitor when the existing National Record is bettered by him/her. In case an existing National Record is bettered by an athlete/competitor in the event more than once during a National Games, only his/her best performance would be considered for award of points. Sports of Karate, Judo, Taekwondo, Wushu and Wrestling shall also workout their results upto 6th position.

9.3 TEAM EVENTS/RELAYS ETC. HAVING PARTICIPATION OF MORE THAN TWO (2) PLAYERS:-

9.5 In both the above categories of Team Sports, 6 top teams belonging to the affiliated Units of POA and qualified on the basis of the last National Championship or Pre-qualification Competitions held for this purpose including the host Unit shall participate in the Games. The intimation of the Teams and Units shall be sent by the Federation concerned to the Organizing Committee and the POA atleast 30 days before the commencement of the Games.

9.6 TURN OUT POINTS IN THE OPENING CEREMONY

The Award of Points for Turn out (uniformity of dress and March Past etc.) shall be determined as under:-

9.7 Uniformity may be defined as similarity / symmetry of dress of one member Unit whatever simple and in whatever design it may be, and must distinctively consist of Track Suit with Joggers and P. Caps for all participants. Each Unit is proposed to be placed distinctively in the following ladder of points on the basis of their Turn out:-

9.8 Within the given definition and criteria, the size of the Contingent at the March Past shall correspond to the total entry. Minimum number of athletes and team officials shall not be less than two third (2/3) of the total entry. March Past may be informal but disciplined and must exhibit grace on the part of athletes / participants. Conduct of a player / Contingent official of a Unit during the entire process of March Past and Assembly at the time of Opening Ceremony shall also be a vital factor for evaluation and grading.

9.9 Cameras, Bags, Mobile Phone etc. shall not be carried by any of the participant of the March Past.

RULE 10

MISCONDUCT / PENALTY POINTS

On and off the field, misconduct / misbehavior by any competitor / official of a participating Unit shall be penalized upto 150 points by the Evaluation and Tabulation Committee according to the gravity of the offence(s) and on a report of the Secretary of the concerned Federation / Organizing Secretary of the Games / Secretary General, POA.

RULE 11

APPOINTMENT OF EVALUATION AND TABULATION COMMITTEE

The Secretary General, POA will appoint, with the approval of the President POA the Evaluation and Tabulation Committee including its Chairman and one technically qualified representative of the Organizing Committee with other 3 or more members with sufficient experience and sports background who shall not be active official / office bearer of any of the participating Units.

RULE 12

SPONSORSHIP

12.1 Since the grants from the Federal Government / Provincial Government are limited and quite inadequate to meet the total financial requirements of the Games, the sponsorship will have to be explored for all the Inter Provincial Games. The host Provincial Olympic Association / Organizing Committee shall find out the sponsors. To regulate the Sponsorship Programme, there shall be 2 members nominated by the President / Secretary General POA on the Sponsorship Committee to coordinate in the efforts and ensure regulate the system.

12.2 The sponsorship amount received for the Inter Provincial Games shall be shared as under:-

i.	Organizing Committee holding the Inter Provincial Games	60%
ii.	Host Provincial Olympic Association	10 %
iii.	Pakistan Olympic Association	10%
iv.	National Sports Federations whose sports disciplines are included in the Games.	10%
v.	Participating Provincial Olympic Association	10%

RULE 13

SPECIAL INVITATIONS

The Organizing Committee shall extend special invitations in writing 3 – 4 weeks before the commencement of the Inter Provincial Games to the following:-

- President of the NOC Pakistan
- IOC Member in Pakistan
- Vice Presidents of NOC Pakistan
- Secretary General NOC Pakistan
- Associate Secretaries General NOC Pakistan

RULE 14

FACILITIES

The concerned Provincial Olympic Association / Organizing Committee of the Inter Provincial Games shall provide the following facilities during the National Games:-

14.1 PROVINCIAL CONTINGENT

The Provincial Contingents including the competitors, team officials and the contingent officials like Chef de Mission Deputy Chef de Mission and Secretary if the strength of the Contingent is more than 200 persons, Doctor and the Treasurer etc. shall be eligible for the following facilities:-

i. LODGING

Accommodation shall be provided in a suitable hotel for 7 days (if the Games are for 5 days – 1 day before and 1 day after the Games). The Contingent Officials mentioned above shall stay with their contingents in the same hotel where other members are accommodated.

ii. DAILY ALLOWANCE

- a. Rs.500/- (minimum) per day per head for participating Provincial Contingents (athletes / competitors and team officials) for 7 days or actual whichever is less.
- b. The Contingent Officials will be entitled to Rs.700/- (minimum) per head per day for 8 days.
- c. Daily Allowance Rules shall be revised after every two years for all categories.

iii. TRANSPORT

- a. The Provincial Chef de Mission will be entitled for a dedicated car.
- b. Dy. Chef de Mission and Secretary of the Provincial Contingent one Car.
- c. For movement of other officials of Provincial Contingent during the Games one Van for each Participating Province.
- d. The Team Officials and Athletes of Provincial Contingents to be provided transport on arrival/departure and during the Games.
- e. In case transport is not provided to the team officials and athletes of Provincial contingent the daily conveyance allowance shall be Rs.200/- (minimum) instead of Rs. 100/- per day per person.
- f. In any case, the Provincial Chef de Mission and the Contingent Officials shall be provided atleast one Car and one Van each participating Province.

14.2 TECHNICAL OFFICIALS

Optimum number of Technical Officials shall be nominated by the concerned National Sports Federations whose strength shall be finalized in the meeting of the Secretaries of the National Sports Federations to be held 2 months and 15 days prior to the National Games respectively. Efforts will be made by the National Sports Federations to acquire the services of maximum number available from the host city / province who are technically qualified to act as Technical Officials during the Inter Provincial Games.

i. TRAVELING ALLOWANCE

The Technical Officials belonging to out-stations shall be entitled to 1st Class Railway Sleeper both ways from the Provincial Headquarters to which they belong upto the city of the Inter Provincial Games.

ii. ACCOMMODATION

A suitable hotel accommodation will be provided to each Technical Official coming from outstation. The list of the Technical Officials would be preferably decided in the first meeting of the Secretaries 2 months before the Games clearly identifying as to which official would be required to provide hotel accommodation and in what manner?

iii. DAILY ALLOWANCE AND CONVEYANCE ALLOWANCE

- Daily Allowance to Technical Officials will be Rs.600/- (minimum) per head per day for 7 days or actual whichever is less.
- Conveyance to and from the playing area to residences shall be provided to Technical Officials or in lieu thereof conveyance allowance shall be given for the number of days they stay during the Games for performance of their duties including the arrival/departure day @ Rs.200/- per day per person.

14.3 FACILITIES TO THE PRESIDENT & SECRETARIES OF THE NATIONAL SPORTS FEDERATIONS, PARTICIPATING UNITS, POA OFFICIALS

- Reimbursement of Economy Class return Air Ticket (where applicable).
- Daily Allowance at Rs.1000/- (minimum) per head per day to the Presidents / Secretaries of National Sports Federations, Participating Units and POA Officials for 7 days or actual whichever is less.
- Chauffeur driven car for maximum 7 days or Rs.600/- per head per day as Conveyance Allowance in case the car is not made available for 7 days or for the actual number of days.
- Atleast 3-Star (A.C) hotel accommodation to the Presidents and Secretaries of the National Sports Federations as well as those of all Participating Units for maximum 7 days or as per their actual stay.
- The President, Secretary General/Chairman/Members of POA Sports Commission and other Senior Officials appointed by the POA for the National Games shall be entitled to the same facilities as in the case of Presidents and Secretaries of the National Sports Federations.

14.4 EVALUATION AND TABULATION COMMITTEE

- The Chairman and Members of the Evaluation and Tabulation Committee shall be entitled to the same facilities as admissible to the President and Secretaries of the National Sports Federations.

- ii. The staff appointed by the Secretary General POA to assist the Evaluation and Tabulation Committee shall be entitled to the same facilities as provided for the Technical Officials, and they will work in close coordination with the Chairman, Evaluation and Tabulation Committee.

RULE 15

SEATING ARRANGEMENTS

The Organizing Committee will ensure that the President NOC Pakistan, IOC Member in Pakistan, Vice Presidents, Secretary General, Associate Secretaries General, Treasurer or any other office-bearer of Pakistan Olympic Association and the Presidents of all the National Sports Federations and of all the Participating Units are seated in VVIP Block. However, the Secretaries and two other Senior office-bearers each of the National Sports Federations and of the Participating Units shall have seats in VIP Block.

RULE 16

JURY OF APPEAL

16.1 Each National Sport Federation whose sports discipline is included in the programme of the National Games shall appoint a Jury to sort out and decide all technical matters related to their competitions.


16.2 An overall Jury for the Inter Provincial Games shall be appointed by the President POA which shall be the final Court of Appeal for all matters related to the Games. The verdict of this Jury shall be final and binding on all.

RULE 17

MISCELLANEOUS

17.1 The competitions in each sports discipline during the Inter Provincial Games shall not be titled as Provincial Championship or Inter Provincial Championship of the concerned sport.

17.2 A plaque to be provided by the Organizing Committee and a Role of Honour to be provided by POA shall be awarded by the Chief Guest on the Closing Ceremony to the Athlete(s) / Competitor(s) who better the existing National Record(s).
