INSTRUCTIONS TO CANDIDATE

(Please read carefully before completing the nomination paper)

1. The Candidate must fill in the Nomination Paper carefully and accurately.
2. The Candidate must mention the name of Office at **Box "A"** in PART I for which Nomination Papers are being submitted.
3. The names in the relevant boxes must match the names on the CNIC cards of the Candidate, nominee and Seconders.
4. All information required must be filled in. NO question or information box be left empty.
5. Clear photocopies of CNIC of the candidate, Nominee and Seconders must be attached with the Nomination Paper otherwise Nomination Paper shall not be entertained by the Election Commission.
6. The Nomination Paper must be submitted with the Election Commission in person by the candidate or the person duly authorized to submit the Nomination Paper otherwise it shall not be accepted.
7. The Candidate should NOT fill in Part III-B and Part IV.
8. Part III-A must be signed before the representative of the Election Commission.
9. The Candidate will be given the Receipt of Submission of Papers.
10. Nomination Paper must be submitted and deposited with the Election Commission at the Headquarters of the Pakistan Olympic Association at **2-Hameed Nizami (Temple) Road, Lahore** or otherwise contact Secretary Election Commission for alternative arrangements.
11. The decisions of Scrutiny Committee and Appellant Bench shall be communicated to the Candidate preferably by Email. Hence all candidates are required to provide a valid Email address, otherwise it will be informed by Telephone / SMS or sent by courier on the address of the Candidate mentioned by him in this form.
12. No Candidate shall be permitted to alter or amend the contents of the Nomination Paper after it has been submitted and deposited with the Election Commission.
13. If any Candidate has an objection to Representative of the Election Commission not receiving the Nomination Paper may contact the Secretary Election Commission and submit the Nomination Paper directly to the Secretary to the Election Commission after having an appointment from him.
14. No proxy vote shall be allowed (Article VIII Clause-6 of POA constitution).
15. Only the candidate under the age of 75 years shall be eligible to contest the elections (Article-IX Clause-3(b) of P.O.A constitution).
